Additionally, statutes can include exceptions for specific communities based on regional circumstances. 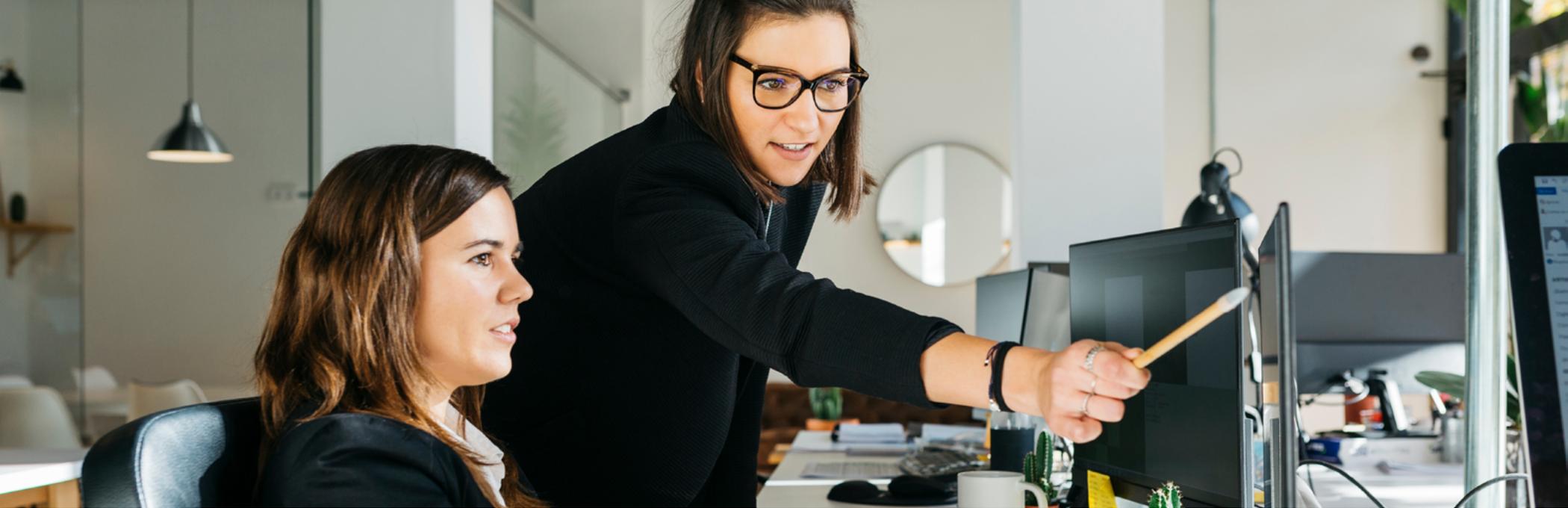
